COUNT I

I, GERALD A. HORNE, Prosecuting Attorney for Pierce County, in the name and by the authority of the State of Washington, do accuse DALE ALLEN OYA of the crime of ASSAULT IN THE FIRST DEGREE, committed as follows:

That DALE ALLEN OYA, in the State of Washington, on or about the 15th day of December, 2005, did unlawfully and feloniously, with intent to inflict great bodily harm, intentionally assault Daquan Stallworth with a firearm or deadly weapon or by any force or means likely to produce great bodily harm or death, contrary to RCW 9A.36.011(1)(a), and in the commission thereof the defendant, or an accomplice, was armed with a firearm, to-wit: a handgun, that being a firearm as defined in RCW 9.41.010, and invoking the provisions of RCW 9.94A.310/9.94A.510, and adding additional time to the presumptive sentence as provided in RCW 9.94A.370/9.94A.530, and against the peace and dignity of the




